UPDATED NOTICE

PLEASE TAKE NOTICE that on the 17th day of January 2026, this Hearing Panel, appointed in accordance with Title IV of the Canons of the Episcopal Church, and in accordance with the Canons of the Diocese of Virginia received from the Church Attorney an Updated Statement of Alleged Offenses of The Rev. Dr. B. Cayce Ramey, Respondent. The Church Attorney's Updated Statement with its exhibits is attached as an Exhibit to this Notice and is made part of it.

This matter arises from allegations that Respondent has violated Canons of the Diocese of Virginia and the Canons of the Episcopal Church as further set forth in the attached Updated Statement of Alleged Offenses. The purpose of this proceeding is to determine whether the allegations constitute offenses under the Canons of the Church, whether Respondent committed the offenses alleged in violation of the Canons, and whether an Order, as set forth in Canon IV.13.13 or IV.14 should be issued.

The names of all persons to whom this Updated Notice is being sent are set forth above. In accordance with Canon IV.13.3 copies of this document, and other documents in that Canon, will be posted on the website of the Diocese of Virginia. (www.episcopalvirginia.org)

THE RESPONDENT MUST FILE A WRITTEN RESPONSE TO THIS UPDATED NOTICE WITH THE HEARING PANEL NO LATER THAN THIRTY DAYS FROM RECEIPT BY EMAIL OF THIS UPDATED NOTICE.

As set out in this Hearing Panel's Notice dated November 4, 2024, the Church Attorney, then Counsel for Respondent and the Hearing Panel agreed that "in accordance with Canon IV.19.20 all notices and all other required documents can be filed by email without receipt confirmed in writing." This agreed method for service of all notices and all other required documents continues. Besides email service, as a special one-time method of service this Updated Notice is additionally being served as authorized by Canon IV.19.20 on the Respondent by certified mail because the Hearing Panel is uninformed as to whether Respondent is represented by counsel. Respondent has not responded to multiple requests as to whether he has retained new counsel and, if so, the identity and contact information for new counsel.

The Respondent is advised, in accordance with Canon IV.19.6, that in the event of his failure to appear or timely respond in this matter, the Hearing Panel may proceed with the matter in the absence of the Respondent, as set forth in the Canon, notwithstanding his failure to appear or respond.
