**FINAL ORDER OF DISMISSAL WITH PREJUDICE  
OF ALL CLAIMS AND COUNTERCLAIMS INVOLVING  
THE CHURCH OF OUR SAVIOUR AT OATLANDS**

THIS MATTER came on to be heard upon the joint representation of the Church of Our Saviour at Oatlands, the Protestant Episcopal Church in the United States of America, and the Protestant Episcopal Church in the Diocese of Virginia that a Settlement Agreement, dated February 20, 2011, has been entered into among said parties disposing of all claims and counterclaims between them, and further, upon their joint request that said Settlement Agreement be received for filing of record in this case, and that an Order be entered incorporating by reference the terms of said Agreement and dismissing all pending proceedings between the parties, with prejudice.

UPON CONSIDERATION THEREOF, it is hereby

ORDERED that the aforesaid Settlement Agreement, dated February 20, 2011 between the aforesaid parties be received for filing and the terms of said Agreement are adopted and incorporated herein, without merger; and it is further,

ORDERED that all claims and counterclaims between and among the Church of Our Saviour at Oatlands, the Protestant Episcopal Church in the United States of America, and the Protestant Episcopal Church in the Diocese of Virginia in these multi-district proceedings are hereby dismissed with prejudice, and Case CL2007-5364, and those portions of Cases CL 2007-0248724 and CL 2007-1625 relating to the claims and counterclaims between and among said parties shall be regarded henceforth among the closed cases of this Court; and it is further,

ORDERED that the Clerk of the Court shall file attested copies of this Order in the Case files of CL2007-5364 and CL2007-1625; and it is further,

ORDERED that in accordance with the Multiple Claimant Litigation Act, Virginia Code Section 8.01-267.1 *et seq*, the Clerk shall forward an attested copy of this Order to the Clerk of the Loudoun County Circuit Court, to be placed in the case file for Loudoun County Court Civil Action No. 43909.
