ORDER

The Supreme Court of the United States having denied the petition for writ of certiorari of The Church at the Falls – The Falls Church on March 10, 2014, it is hereby

It is further ADJUDGED, ORDERED and DECREED that upon issuance of such checks all obligations of The Church at the Falls – The Falls Church under the Final Order in this matter entered on March 1, 2012, and corrected on March 16, 2012, Nunc Pro Tunc to March 1, 2012 and further corrected by Order on Remand to Correct Error in Judgment on September 17, 2013 (collectively the “Final Order”) have been satisfied.

It is further ADJUDGED, ORDERED and DECREED that the Clerk of Court for the Circuit Court of Fairfax County is hereby instructed to mark in the docket of the Court all judgments against The Church at the Falls – The Falls Church in the following cases as SATISFIED:

Multi-Circuit Episcopal Church Property Litigation (Circuit Court of Fairfax County No. CL-2007-0248724);

The Protestant Episcopal Church in the Diocese of Virginia v. The Church At The Falls – The Falls Church (Circuit Court of Fairfax County; CL 2007-5250) (Circuit Court of Arlington County Case No. 07-125); and

The Episcopal Church v. Truro Church et al. (Circuit Court of Fairfax County; CL 2007-1625);


