**THE CHURCH AT THE FALLS - THE FALLS CHURCH'S REPLY BRIEF
IN SUPPORT OF ITS MOTION TO SUSPEND EXECUTION
OF THE FINAL ORDER AND TO SET THE SUPERSEDEAS BOND**

The Church at the Falls – The Falls Church (“TFCA”), by counsel, pursuant to Virginia Code § 8.01-676.1 and in support of its motion to suspend execution of the Final Order, entered on March 1, 2012, and to Set Supersedeas Bond hereby replies to the Diocese of Virginia’s and the Episcopal Church’s Opposition (collectively the “Diocese”).

I. RULE 1:1 DOES NOT APPLY TO THIS MOTION

The position of TEC and the Diocese that Rule 1.1 deprives the Court of jurisdiction to stay its judgment here is squarely foreclosed by Virginia law. To begin with, plaintiffs’ position is irreconcilable with the text of Va. Code § 8.01-676.1, which makes suspension of the judgment *automatic* upon the posting of appropriate security. Further, plaintiffs’ position cannot be reconciled with binding Virginia Supreme court precedent holding that Rule 1:1 is inapplicable to “[a] stay order,” which “merely postpones the date when a final judgment will be executed” and “does not alter the substantive provisions of that final judgment.” Davidson v. Commonwealth, 246 Va. 168, 179-80 (1993). Finally, plaintiffs’ position rests on the

implausible notion that circuit courts, after 21 days, retain jurisdiction to *enforce* their orders (the greater power), but lack jurisdiction to *suspend enforcement* of their orders.

A: Upon Posting Of Suitable Security, Virginia Code §8.01-676.1(C) Provides An Automatic Suspension Of The Execution Of The Judgment Which Is Not Limited By The Twenty-One Day Period Set Forth In Rule 1:1

The relevant parts of Virginia Code § 8.01-676.1 are subsections B, C, I, J, J1, and L, which read as follows:

B. Security for costs on petition for appeal to Court of Appeals or Supreme Court. - An appellant whose petition for appeal is granted by the Court of Appeals or the Supreme Court shall (if he has not done so) within 15 days from the date of the Certificate of Appeal file an appeal bond or irrevocable letter of credit in the same penalty as provided in subsection A, conditioned on the payment of all damages, costs, and fees incurred in the Court of Appeals and in the Supreme Court.

C. Security for suspension of execution.--An appellant who wishes execution of the judgment or award from which an appeal is sought to be suspended during the appeal shall, subject to the provisions of subsection J, file an appeal bond or irrevocable letter of credit conditioned upon the performance or satisfaction of the judgment and payment of all damages incurred in consequence of such suspension, and except as provided in subsection D, execution shall be suspended upon the filing of such security and the timely prosecution of such appeal. Such security shall be continuing and additional security shall not be necessary except as to any additional amount which may be added or to any additional requirement which may be imposed by the courts.

D. Suspension of execution in decrees for support and custody; injunctions. - The court from which an appeal is sought may refuse to suspend the execution of decrees for support and custody, and may also refuse suspension when a judgment refuses, grants, modifies, or dissolves an injunction.

....

I. Forms of bonds; letters of credit; where filed.--The Clerk of the Supreme Court shall prescribe separate forms for appeal bonds, one for costs alone, one for suspension of execution, and one for both and a form for irrevocable letters of credit, to which the bond or bonds or irrevocable letters of credit given shall substantially conform. The forms for each bond and the letter of credit shall be published in the Rules of Court. It shall be sufficient if the bond or letter of credit, when executed as required, is filed with the trial court, clerk of the Virginia Workers' Compensation Commission, or the clerk of the State Corporation Commission, whichever is applicable, and no personal appearance in the trial court, Virginia Workers' Compensation Commission, or State Corporation

Commission by the principal, the surety on the bond or the bank issuing the letter of credit shall be required as a condition precedent to its filing.

J. In any civil litigation under any legal theory, the amount of the appeal bond or irrevocable letter of credit to be furnished during the pendency of all appeals or discretionary reviews of any judgment granting legal, equitable, or any other form of relief in order to stay the execution thereon during the entire course of appellate review by any courts shall be set in accordance with applicable laws or court rules, except that the total appeal bond or irrevocable letter of credit that is required of an appellant and all of its affiliates shall not exceed \$25 million, regardless of the value of the judgment.

J1. Any objection to or motion for modification of the form, amount, or issuer of any letter of credit or bond may be made to, and decided by, the Court of Appeals or the Supreme Court. Any objection to or motion for modification of the form, amount, or issuer of any letter of credit or bond may also be made to, and decided by, the court or commission whose decision is being appealed at any time until the Court of Appeals or the Supreme Court acts upon any similar motion.

L. For good cause shown, a court may otherwise waive the filing of an appeal bond or irrevocable letter of credit as to the damages in excess of, or other than, the compensatory damages.

See Virginia Code § 8.01-676.1.

Section § 8.01-676.1 provides for an automatic suspension of execution of a judgment when sufficient security has been posted to protect the Appellee's interests during appeal. Neither Rule 1:1 nor its twenty-one day provision limit the application of § 8.01-676.1.

Under § 8.01-676.1, when an appellant like TFCA wants the execution of the judgment to be suspended during the pendency of the appeal, a bond or irrevocable letter of credit for the suspension must be filed with the trial court. See § 8.01-676.1(C) ("An appellant who wishes execution of the judgment ... to be suspended during the appeal shall ... file an appeal bond") **and** (I) ("It shall be sufficient if the bond ... when executed as required is filed with the trial court"). Upon the filing of the supersedeas bond per Subsection C with the trial court, together with the timely prosecution of the appeal, the judgment is suspended *automatically* by operation of law. As plainly set forth in the statute, "execution **shall be suspended** upon the filing of such

security and the timely prosecution of such appeal.”) (emphasis added). See § 8.01-676.1(C).

The Diocese’s unsupported contention that Subsection C only applies to money awards, and is therefore inapposite here, is directly contradicted by the language of statute itself. First, Subsection C expressly addresses both the terms “judgment” *and* “award” and nowhere qualifies either with the term “money.” As such, Subsection C embraces the Final Order, entered on March 1, 2012. The term “judgment” is defined in Virginia as “[a] court's final determination of the rights and obligations of the parties in a case. The term *judgment* includes an equitable decree and any order from which an appeal lies.” Comcast of Chesterfield County, Inc. v. Board of Supervisors of Chesterfield County, 277 Va. 293, 306 (2009) (quoting Black's Law Dictionary 858 (8th ed. 2004)). Virginia Code § 8.01-2(2) provides that the terms “decree” and “judgment” may be used “interchangeably and shall include orders and awards.” Thus, the term *judgment* in § 8.01-676.1 is not limited to money judgments.

Second, Subsection C simply requires a bond, or irrevocable letter of credit, conditioned upon the performance or satisfaction of the judgment and payment of all damages incurred in consequence of such suspension. The Diocese’s narrow interpretation cannot be read into the statute’s requirements. If so, the statutory language would have been limited solely to “the payment of all money damages” not with the additional condition of “the performance or satisfaction of the judgment.”

Third, Subsection J settles the broad application of § 8.01-676.1, thereby repudiating the Diocese’s narrow application. That Subsection states that “[i]n any civil litigation *under any legal theory*, the amount of the appeal bond or irrevocable letter of credit to be furnished during the pendency of all appeals ... of any judgment granting *legal, equitable, or any other form of*

relief in order to stay the execution ... shall be set in accordance with applicable laws or court rules” *See* § 8.01-676.1(J) (emphasis added).

The issue that remains then is the amount of the bond. That this Court has jurisdiction to entertain this question is also borne out in a plain reading of the statute. Consistent with Subsection J1, the appellee may object to the form, the amount, or the issuer of the supersedeas bond in **the trial court** from which the matter is being appeal. *See* § 8.01-676.1(J1) (“Any objection to ... amount ... may also be made to, and decided by, the court ... whose decision is being appealed at any time until ... the Supreme Court acts upon any similar motion.”). In other words, the trial court is not stripped of its jurisdiction to decide the sufficiency of the amount of a supersedeas bond because 21 days since the final judgment has passed. The sufficiency of the supersedeas bond is not a Rule 1:1 issue. It is instead a § 8.01-676.1, which clearly vests the trial court with concurrent jurisdiction over the bond amount.

As to the amount of the bond, the statute directs that the supersedeas bond shall be subject to Subsection J and conditioned upon the performance of the judgment and payment of all damages incurred as a result of the suspension during the pendency of the appeal. *See* § 8.01-676.1(C). Subsection J further directs that the supersedeas bond be set “in accordance with applicable laws or court rules,” without any further instruction than to set the outer limit of such a bond to \$25 million. *See* § 8.01-676.1(J). Subsection L further permits the trial court to waive the filing of such a bond as to any damages in excess of, or other than, compensatory damages.¹

Finally, the automatic application of § 8.01-676.1, with the trial court’s involvement of the bond, does not end upon the expiration of Rule 1:1’s twenty-one day period.

¹ *See also, M’Kay v. Hite's Ex'rs*, 25 Va. 564, 564-65 (1826) (“an appeal must be allowed on the appellant giving security merely to perform the decree of the Inferior Court, and to pay costs and damages awarded here, if the decree shall be affirmed. This will be a small sum sufficient to cover the costs in the Court below.”)

Subsection B of § 8.01-676.1 allows 15 days from the granting of petition of appeal (which itself was not due until 30 days from TFCA has 30 days from the March 1, 2012 order under Virginia Code § 8.01-671) to file an appeal bond. Pursuant to Subsections C and I, a supersedeas bond can then be filed as two separate bonds or combined into one bond.² See § 8.01-676.1 (C) and (I).

B. Section 8.01-676.1 and Rule 1:1 Address Different Functions

Section 8.01-676.1 is compatible with, but places limitations upon, this Court's continuing jurisdiction to control the execution of its judgment. Rule 1:1 provides that a final judgment, order or decree will remain under control of the trial court and subject to be modified, vacated or suspended for twenty-one days and no longer. On its face, Rule 1:1 addresses the modification, vacation or suspension of a final judgment. By contrast, § 8.01-676.1 does not address the modification, vacation or suspension of a judgment. Rather, § 8.01-676.1 addresses only suspension of the execution of a judgment. Under § 8.01-676.1, the judgment would remain in place unmodified, unvacated and unsuspended.

The trial Court's continuing jurisdiction to issue orders relating to execution of its judgment is commonplace and accepted. In Upper Occoquan v. Blake Construction Co., 275 Va. 41, 60-61, 655 S.E.2d 10 (2008), the Virginia Supreme Court affirmed this Court's continuing jurisdiction to determine and change the amount due on a judgment. In Fisher v. Salute, 51 Va. App. 293, 657 S.E.2d 169 (2008), Virginia's Court of Appeals held that, despite passage of Rule 1:1 twenty-one day period, the trial court retained jurisdiction to consider enforcement proceedings, including a show-cause proceeding for contempt.

² See Rule 5:24(a) ("All security for appeal required under Code § 8.01-676.1 shall substantially conform to the forms set forth in the Appendix to this Part Five"). The Appendix provides the forms for both.

Two decisions demonstrate the distinction between modifying, vacating, or suspending a judgment on the one hand and suspending *execution* of a judgment on the other hand. In Davidson v. Commonwealth, 246 Va. 168 (1993), a civil habeas proceeding, the Supreme Court held “that Rule 1:1 does not preclude the entry of an order staying an execution date because such an order would not modify, vacate, or suspend a capital murder conviction and sentence of death. *A stay order merely postpones the date when a final judgment will be executed; it does not alter the substantive provisions of that final judgment. Thus, a stay order is distinguishable from an order suspending a previously-imposed sentence, such as that considered in In re: Dept. of Corrections*, 222 Va. 454, 463, 281 S.E.2d 857, 862 (1981).” 246 Va. at 179-80. (emphasis added)³ :The same reasoning applies here.

By contrast, Reynolds v. Commonwealth, 2001 WL 32659 (Va. Ct. App., Jan. 16, 2001), an unpublished opinion of the Virginia Court of Appeals, turned on Reynolds’ Motion to stay the judgment and motion to set aside his guilty pleas to several counts. Because the Rule 1:1 twenty-one day period had passed without rulings from the trial court, the Court of Appeals held that denial of the motion to set aside the guilty pleas was not appealable because the trial court had no jurisdiction to grant the motion. As opposed to the suspension of execution of the judgment in Davidson, setting aside Reynolds’ guilty pleas would have resulted in a fundamental change in the judgment which was based on those pleas.

³ A habeas proceeding is a civil proceeding. See Commonwealth v. Southerly, 262 Va. 294, 297-98, 551 S.E.2d 650, 652 (2001) (“The Commonwealth cites Virginia Dept. of Corr. v. Crowley, 227 Va. 254, 316 S.E.2d 439 (1984). There, we held that motions to vacate orders releasing convicted felons from custody and appeals from the denial of the motions were civil in nature. Id. at 263, 316 S.E.2d at 443-333. We likened such motions and appeals to petitions for habeas corpus and appeals from orders granting habeas relief. Id. We observed that ‘habeas corpus is a civil and not a criminal proceeding’ and ‘in no sense a continuation of the criminal prosecution.’ Id. at 262, 316 S.E.2d at 443 (quoting Smyth v. Godwin, 188 Va. 753, 760, 51 S.E.2d 230, 233, cert. denied, 337 U.S. 946, 69 S.Ct. 1503, 93 L.Ed. 1748 (1949)).”)

Recent proceedings in this Court reinforce that, of course, this Court retains jurisdiction over the execution of its Final Order. The Diocese recently filed a Motion to Enforce the Final Order against Truro Church requesting that this Court find that the final amount of liquid property owed to the Diocese by Truro under Section E is at least \$72,421, award costs and fees, and award other and further relief. The Diocese also recently filed a Notice of Continuing Disputes Concerning Liquid Personal Property reserving the right to seek enforcement of the Final Order in which this Court would determine the amounts of liquid personal property to be conveyed under the Final Order. The Final Order also necessitates that this Court retain the power to determine the amount of any money judgment which might arise from a congregation's failure to pay the amounts due. See, Final Order at page 10. Clearly, the Diocese does not proffer that this Court lacks jurisdiction to address and issues orders concerning the execution of the Final Order. Plaintiffs' position thus rests on the untenable position that the Court retains the greater power to enforce its orders after 21 days, but not the lesser power of suspending their execution pending resolution of an appeal.

II. THE FEDERAL STANDARDS FOR GRANTING A PRELIMINARY INJUNCTION ARE INAPPLICABLE HERE

As is discussed above, § 8.01-676.1 provides for an automatic suspension of execution of a judgment upon the posting of adequate security. Further, despite the passage of Rule 1:1 twenty-one day period, § 8.01-676.1 allows the trial court to determine the amount of the required security subject to limitations posed by § 8.01-676.1. The Diocese wrongfully attempts to engraft on this process a requirement that TFCA satisfy the federal standards for the issuance of a preliminary injunction. Its argument is a house of cards built upon one unsupported proposition after another.

First, the Diocese cites to one U.S. Supreme Court case, Nken v. Holder, 556 U.S. 418,

129 S.Ct. 1749 (2009) for the proposition that suspension of execution of a judgment pending appeal should be based on the factors used for issuance of a preliminary injunction. But a court's stay of a decision under review and its enjoining of a private party to act are two different things and the Diocese cites no Virginia law in support of its position. This is not surprising since Virginia law is to the contrary. Under § 8.01-676.1, the only factor to be considered for suspension of execution of a judgment is the posting of adequate security. Section 8.01-676.1 makes no mention of likelihood of success on the merits, irreparable harm, harm to the Appellee or the public interest. Simply put, suspension of execution of a judgment pending appeal is an ordinary, everyday process; issuance of a preliminary injunction is an extraordinary remedy which should only be invoked with great care and consideration of the consequences.

Next, the Diocese proffers that this Court must adopt the federal standard for issuance of a preliminary injunction. Their support for this proposition is several Virginia Circuit Court cases, none of which address a suspension of execution of judgment and most of which clearly state that: "The Virginia Supreme Court has not yet decided a case that delineates the standards to be applied in granting or denying a preliminary injunction." See, for example, Christian Defense Fund v. Winchell, 68 Va. Cir. 83, 2004 WL 2848402 (Va. Cir. Ct. 2004).

Finally, the Diocese proffers the rather extraordinary proposition that no stay pending appeal can issue unless this Court first determines that TFCA has a substantial likelihood of success on the merits. According to the Diocese, no stay is appropriate unless this Court, in effect, reverses itself. This would be, of course, a gross decimation of § 8.01-676.1.

III. THE CONDITIONS PROPOSED IN TFCA'S MOTION WILL PROVIDE ADEQUATE SECURITY TO PROTECT THE DIOCESE'S INTERESTS DURING THE APPEAL

In the case of a monetary award, setting the amount of a supersedeas bond is fairly

straightforward. However, when, as here, the Final Order is not a money judgment and directs conveyance of real and personal property, setting the bond takes a bit more thought. As noted in Tauber v. Commissioner, 236 Va. 520, 525 (2002), the purpose of the supersedeas bond is to provide security for the Appellee during the appeal process.

In Paragraph 14 of its Motion, TFCA proposed eleven conditions to the suspension of execution of the Final Order pending appeal. One proposed condition tracks the provisions of the Final Order and would require payment of the amount of the liquid personal property into the registry of the Court along with nine months' interest at 6% per annum. See TFCA's Motion at pages 4-5. The Diocese and TFCA have reached basic agreement on the amount of the liquid personal property at \$2,719,186.70, although we are still gathering information on two minor accounts which we believe contained about \$200.00 on January 31, 2007. TFCA requests that the Court set the amount of the supersedeas bond at \$2,842,400.00 to be posted by payment of cash into the registry of the Court. This amount includes a principal amount of \$2,720,000.00 plus interest of \$122,400.00 (9 months at 6% per annum). TFCA respectfully submits that the conditions which it proposed adequately secure the Diocese's interests.

In the Opposition, the Diocese generally endorses the conditions proposed by TFCA and proposes three additional conditions. Opposition at pages 11-13. TFCA objects to two of the three additional conditions.

First, the Diocese and TEC request that the Diocese be paid the rental values of the properties. TFCA suggests that this proposal is overreaching. The conditions proposed by TFCA include the requirement that TFCA continue to maintain, insure, protect and preserve the property during the appeal. The evidence is that such preservation of the property entails expenditure of hundreds of thousands of dollars per year. See, DX-FALLS-0073A-000001.

These are expenses which the Diocese would have to bear if execution is not suspended. It is overreaching for the Diocese to demand that TFCA bear these expenses and still pay additional amounts in rent – particularly when the Diocese has not indicated that it plans to rent out the facility if it were the sole occupant or could realize any substantial rent from a short-term lease of the premises.

TFCA notes that the Episcopal Congregation was not paying rent or anything else to the Diocese prior to disaffiliation. If execution is not suspended and The Falls Church (Episcopal) (“TFCE”) moves into the property, it would be very surprising if TFCE paid rent to the Diocese. TFCA notes that, according to its 2010 Annual Report, the continuing congregation is paying The Falls Church Presbyterian Church approximately \$750.00 per month for use of the facilities. See, DX-FALLS-0312-000026. TFCA would agree to a condition that TFCA pay TFCE \$750.00 per month to cover this rent.

Second, the Diocese proposes that TFCE have regular use of the Historic Church and related offices. TFCA opposes this proposal. Throughout this litigation, it has been clear that fundamental differences in theology and the teaching of Scripture have developed between the Diocese/TEC and TFCA. These differences have led the members of TFCA to the agonizing decision to sever the affiliation with the Diocese and TEC. Both sides have recognized the importance of a complete break to avoid confusion among the public. Thus, the Diocese and TEC have insisted that TFCA not use any name, websites, signage or other media which suggests some continuing connection between TFCA and them. TFCA believes that regular, dual services at the property would lead to confusion among parishioners who would have to decide which door to enter. In addition, TFCA regularly uses the Historic Church and needs that space.

Third, the Diocese proposes a condition that TFCA implement changes to website domains contemplated by Section H of the Final Order which would required the TFCA use the word "Anglican" rather than the word "Episcopal" to describe itself. TFCA is already in the process of making such changes because, as noted above, TFCA agrees that it is in both sides' best interest to avoid public confusion by making it clear that there is no ongoing connection between the parties.

WHEREFORE, The Church at the Falls – The Falls Church prays that this Honorable Court enter an order suspending execution of the Final Order upon the conditions stated in TFCA's Motion to Suspend Execution of the Final Order and to Set the Supersedeas Bond and directing plaintiffs not to take any steps to enforce or execute the Final Order until all appeals in this case have been exhausted, and for such further and additional relief as this Court deems just and proper.



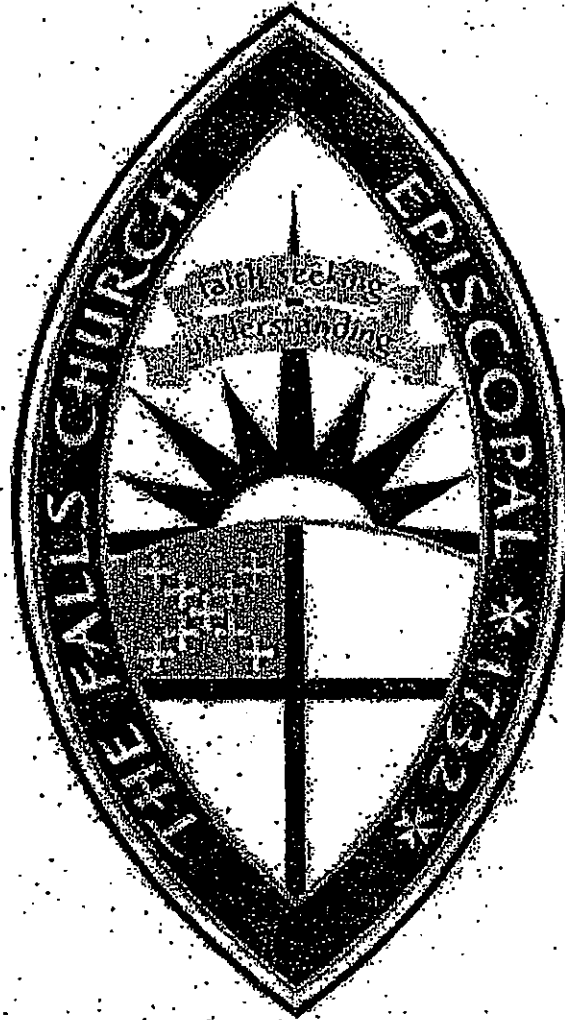

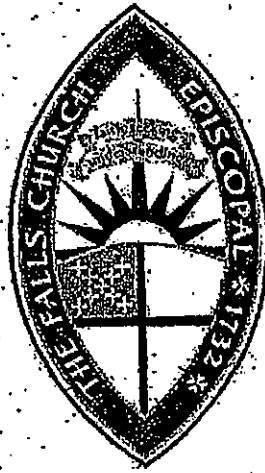

Founded in 1732 as a chapel of Truro Parish (later Fairfax Parish), a colonial parish of the Church of England. As such, The Falls Church (Episcopal) finds resonance with its Anglican roots, expressed through worship, service, and fellowship. The Seal incorporates both the shield of The Episcopal Church and the Compass Rose of the Anglican Communion, both to which The Falls Church (Episcopal) proudly belongs. The phrase "Faith Seeking Understanding" is a quote from St. Anselm, former Archbishop of Canterbury, and it symbolizes our desire to not only believe, but that through believing we might come to understand and see God.

ABOUT US

We are a congregation of believers in Jesus Christ as the Way, the Truth and the Life. Our theology is always informed by listening to Holy Scripture, the traditions of the church, human reason, and the experience of Christians discerned in community.

Our theology is both Orthodox and Open, and we seek to exercise this, not through conflict or denominationalism, but through service to our neighbors.

For us, Jesus' words are paramount: His commandment summarizes and describes our life together: "You shall love the Lord your God with all your heart, and with all your soul, and with all your mind...[and] you shall love your neighbor as yourself."

We believe that all Christians are called to unity under one Lord, and our unity is Christ, not conformity of opinion. As we continue to discern the presence and will of God, we pray for this unity, that our witness to the world would not be one of strife, but one of love.

We are a worship-centered community, gathering weekly to be fed and nourished by the experience of God in community.

Of the many blessings of 2010, I am particularly thankful for the generosity of the Vestry and of all of the members of TFCE for the time that was given to me for paternity leave and for continuing education/sabbatical time during the summer. When Molly and I welcomed Elliott to our family in March, it was especially helpful to spend two weeks adjusting to fatherhood and settling into life with our son. Indeed, I am continuing to learn and benefit from the wisdom of many fathers in our congregation, and your advice and admonitions of patience have been especially helpful. Thank you.

As many of you know, I am nearing the end of my studies for a Doctor in Ministry (D.Min). When I came to The Falls Church (Episcopal) in January of 2007, I had just begun the classroom work, but I took a break to focus on the mission and needs of our growing parish. I restarted my work toward the D.Min in October of 2009, and was grateful to be able to use my sabbatical time for a required residency at the seminary. After one last residency period in the summer of 2011, I will embark on writing my dissertation, and then – God willing – I will be awarded my doctorate in May of 2013.

After my time away this summer, I was glad to get back to our parish, and to focus on our continued development and mission.

One aspect of our continued development is the enhancement of our Administrative Ministry, and when Falls Church Presbyterian Church offered us the use of a large office, the Vestry and I jumped at the opportunity to move our "office" from the second floor of my home to a place that was more accessible to you and to our community. I continue to give thanks to God for our friends at Falls Church Presbyterian Church – their partnership with us has given us a place where we can worship joyfully, and now it has given us a place to work and collaborate throughout the week. I want to say "Thank You" to Cathy for helping me paint the new office, and to Kees Dutilh for serving as our General Contractor for various upgrades. I am doubly thankful to the Vestry for allocating the funds for this opportunity, and for the Diocese of Virginia for a special grant that will offset the cost of furniture and some utilities. When you have an opportunity, please offer a personal word of "Thanks" to the Rev. Jon Smoot, FCPC's Interim Pastor, to Jack Sarver, recent Chair of FCPC's Buildings and Grounds Committee, and to the members of FCPC's Session (which is similar to our Vestry).

With regards to worship, we have seen several changes over the past year, including the change in our worship schedule, the increase in attendance, and the development of a few worship ministries, such as the acolytes and ushers. Thanks to Jason Matechak for his leadership in developing a cadre of ushers, and thank you to all of our Acolytes (and their parents!) - Aly Callander, Scott Callander, Kate Karstens, Jakob Karstens, Sally Karstens, Emma Gardner, Lauren Simmons, Jack Matechak, and Alexandra Matechak. Alongside of these two ministries of service, other folks have found ways to respond to God's call in worship through the Altar Guild, Music Ministry, Vergers, by volunteering to help in the Nursery, and by serving as Readers, Chalice Bearers and (occasionally) Preachers. I find myself continually in debt to my staff - the Rev. Cathy Tibbetts and James Jelasic - and to the many dedicated volunteers whose leadership make our worship service especially joyful: Kathi Dutilh (Altar Guild), Bill Forester and Doug Hansen (Vergers), Lillian Anderton (Nursery), and Paul Miller (Lay Readers and Chalice Bearers). Worship is the primary way that we respond to God working in our lives, and I know that when I come to church on Sundays, I can expect to see God moving in and through the lives of these people, and through all who come to offer their gifts. We are truly blessed.

Worship will be an especially important topic in the coming year, as we continue to welcome more visitors and new members. While our Average Sunday Attendance for 2010 is 74 people, if we consider the trend from September through December, our Average Attendance is much higher - nearing 85 people (and recent January 2011 attendance is approaching an average of 100). This is a wonderful opportunity and blessing, and I am thankful that so many people are attracted to the work of God in this place. As we continue to grow, consideration of our vocation to make room for everybody will be important. How will we do this? While many options have been suggested, no decisions have been made, and no decision will be made until we have solicited everybody's input and prayerfully considered how God is calling us to respond to this blessing.

As we welcome more and more newcomers, there must be an acknowledgement of the extraordinary gifts for hospitality exercised by members of this parish. Truly, people come to worship and stay for fellowship - and they are welcomed and fed by some extraordinary people and led by the Parish Life Committee, which is charged with organizing our fellowship ministry. Everything from our weekly Coffee Hour to our Annual

Parish Retreat is organized by Parish Life, and their ministry continues to enrich our community. Thank you to Nancy Councilor for your diligent and faithful work on this committee for three years! I also give thanks for the ongoing ministry of Lee Corey, and for the many folks who help you on Sunday mornings - we have the best coffee hour in Christendom; and I want to also thank Mike Lockaby and Matt Rhodes for your work in putting together the best Parish Retreat that I've ever known, and to Bill and Robin Fetsch for welcoming over 100 parishioners to their home for our 4th Annual Christmas Party.

Our Parish Seal highlights a quote from St. Anselm of Canterbury - "Faith Seeking Understanding." We are called to not only worship and celebrate the work of God in our lives, we are called to learn about how God has worked in and through people and the church throughout the ages, and we are called to an ever-deepening faith that is formed through study. We have been blessed with men and women who not only have a gift for teaching, but who have personally experienced God working in their lives, and they have much to offer all of us as we "seek understanding." In the middle of 2008 we welcomed the Rev. Cathy Tibbetts to our parish, and I asked her to help set up a Sunday School program that would eventually be led by members of the parish. Through her faithful efforts and gifts, she not only set up a Sunday School, but established an entire Children's Education program for our parish that continues to move toward a member-led model. Likewise, in 2009 I asked Margret Hjalmarson to come and help us to continue the development of our Adult Education programs, and with the help of Mike Lockaby, Matt Rhodes, and Doug Hansen, we have developed several excellent offerings for our adult members throughout the year. There is no shortage of opportunity for people of any age to "seek understanding" and I am thankful for these partners in ministry.

Fellowship creates community, worship gives us strength, and education gives us depth - and all of these ministries help us to join in God's work in the world around us. Even as God has blessed us, we are called to bless others, and through the work of our Outreach Committee, we continue to make a difference in people's lives. In 2010, we offered dinners at the local homeless shelter, we helped to rebuild the home of one of our neighbors, we helped to raise funds for our ministry partner - Falls Church Community Service Council, we sent care packages to men and women deployed abroad, we helped local students in need, we shared the fruits of our harvest through Thanksgiving dinners, and we gave the gift of Christmas to local children. In addition to all of this, we collected and donated food to our local food pantry each month, and we helped men and women who came directly to us in need. Each and every member of our parish is a member of our Outreach Ministry - but I am especially grateful to those who help organize our efforts: Sally Brett (Chair), Lillian Anderton, Elizabeth Bass, Neal Callander, Cary Cavness, Kathi and Kees Dutilh, Robin Fetsch, Gretchen and Mike Snyder, Edie Smolinski, and Nancy Councilor.

Finally, I am grateful for the work and ministry of our Vestry - for their dedication in coming to 7:00am meetings (with nary a complaint), for their willingness to take risks knowing that God continues to provide for us all, for their leadership, and for their patience with me and with our growing parish. We have reached a threshold in the life of our congregation, with our membership nearing 200, with growing attendance in programs and worship, and with all of the blessings and opportunities that come from this growth. I continue to give thanks for their friendship and their leadership, and I ask

PRIEST ASSOCIATE REPORT
The Rev. Catherine J. Tibbetts

2010 began with a bang for me. On January 1st, my ministry at TFCE expanded from part-time to full-time ministry. To say that this year has been transformative is quite an understatement. For each of us, our lives and ministries are part of God's unfolding history and offer up fresh opportunities each and every day for worship and service to His glory.

This report on my ministry during 2010 has been organized into seven key discussion areas:

- Worship
- Education / Christian Formation
- Outreach
- Pastoral Care
- Administrative Support
- Diocesan Committees / Ministries
- Continuing Education

Worship: As Episcopalians, worship is central to the way we identify and celebrate our individual and corporate relationship with God, and also with one another. Worship, therefore, is the foundation of all other parts of our lives as followers of Jesus Christ. As a priest of the parish, it is a precious privilege to participate with you, Father Michael and with lay leaders who come together in worship for the Liturgy of the Word and then afterwards gather around Christ's own table to share in the bounty of his grace and



mercy. As I reflect on times of worship this past year that have been most especially significant for me, I have many warm memories of God's transforming power in and amongst us. For me, each gathering is special and unique on its own merits. Often we come and go without knowing all that God has accomplished. Again and again I have been reminded of how crucial worship is for each of us within community. Our decision to participate each week in worship nurtures much more than our own personal needs. Our presence in worship is indeed one of the most important means we exercise in our ministry to one another. In my ministry among you, this coming together for times of common worship is very similar to what we see in Jesus and his coming to live amongst us. Being present for each other is in and of itself a sacramental act of supporting one another along in companioned journeys of faith at TFCE. Even beyond those who are present with us in the act of worship it also is our means of corporately addressing the needs of those

for whom we pray. Accordingly in 2010, I especially reveled in the many times that my ministry brought me into deeper relationship with each of you and your stories of faith. I am ever mindful as I share in leading worship that your presence with me is an integral part of my ongoing journey of faith. As one of your priests, my prayer is that I may be used by God in a manner that best nurtures and supports you in your own journeys.

Education / Christian Formation: Throughout all of our lives, as people of faith and with God's help, we seek to grow into ever deepening knowledge of, and relationship with God in an ongoing process we call *Christian Education* and/or *Christian Formation*. One key focus of my ministry in 2010 was in the area of leadership of Christian Education / Formation within our parish. Such ministry occurs in a variety of different ways.

Certainly this occurs during each Sunday during the Liturgy of the Word but even more so during other programs and ministries such as Sunday morning education for all ages. Of special note in 2010, a group made up of Margret Hjalmarson, Mike Lockaby, Matt Rhodes and Doug Hansen stepped forward to expand TFCE's adult education programs. Additionally, the parents of children at TFCE stepped forward to expand TFCE's children's

Sunday school programs, establishing three distinct classes for children and youth ages 4 - 12th grade. Also in 2010, Tyler Fox, a young adult member of TFCE, stepped forward to assist me with the programming for middle and high school youth at TFCE. For all of these teachers and ministry leaders I give special thanks. In 2011, I see TFCE continuing to expand and strengthen its programming for ongoing Christian Education and Formation under the leadership of an engaged and active Christian Education/Formation Committee that will work closely with me to enact goals and objectives for this ministry that are under development with TFCE's vestry.

Outreach: In 2010, outreach was an important part of my overall ministry. Outreach is near and dear to my heart and to my personal sense of calling. Throughout Jesus' life and teachings we repeatedly see that God expects us as his children to respond assertively care reaching out to those in need. In my ministry during 2010 outreach, the form of "*faith in action*" was integrated into the curriculum and program planning for Christian education/formation with children and youth, including:

- The youth's Lenten retreat which culminated with their feeding 78 homeless individuals at the Bailey's Crossroads shelter;
- The younger children's ingathering of food for the Knox Food Pantry in association with Sunday School and during VBS;
- Our gift of PNO once each month to parents within the community, offering to them the resource of a safe place for them to come and place their children under our care; and

- The annual practice of supporting the children at Christmas time to offer a gift supporting the Episcopal Relief and Development Fund's *Gifts for Life* initiative to those in need around the world.

Pastoral Care: As TFCE has grown this past year, so too have its pastoral needs. Father Michael and I share in this ministry, supported by lay ministers who provide much in the way of support to members during periods when an extra hand is needed. In 2011, I anticipate that this ministry will continue to be a central part of my time and schedule, both in direct care and also alongside Father Michael as we welcome and train lay ministers who are called to join with us in this important ministry.

Administrative Support: There are a variety of necessary administrative tasks that need to be accomplished to support my ministry and the overall life of the parish. In the office, Tuesday—Friday, I work closely with Father Michael on tasks ranging from answering the phones to planning and producing written materials needed for worship, Christian education and other TFCE programs. I participate in weekly staff meetings and various other meetings with Father Michael and other leaders of the TFCE, in coordination meetings with the clergy and staff of Falls Church Presbyterian Church, and from time to time, with meetings within the Falls Church Community that are associated with our programs and ministries. I also participate with Father Michael in monthly regional clergy meetings, in Region 8 Council meetings, and in meetings called by the Bishop in association with the Annual Council and others scheduled for clergy on behalf of the Diocese of Virginia.

Committees / Ministries Outside TFCE: As your priest, and also as a priest of the Diocese of Virginia, it is my privilege to serve from time to time in various capacities. In 2010 some of these included:

- Being one of the homilists at the Falls Church Good Friday Service held at St. Anthony's Roman Catholic Church;
- Leading four workshops as a certified trainer for the diocese's Prevention of Sexual Misconduct training (required for all clergy, staff, and other lay ministers);
- Representing TFCE in Region 8's Youth Leadership Committee (which planned and implemented three youth events in 2010);
- Being the clergy Director for the Diocese's 2010 Family Conference held at Shrine Mont July 11 – 17; and
- Completing the third and final year of membership on the Diocese's Committee on Mental Health.

Continuing Education: Vocationally it is my responsibility to participate in ongoing educational and Christian formation that strengthens my gifts and skills as needed in my ministry as your parish priest. In 2010 my continuing education included:

- Participation during the spring of 2010 in two one-day conferences that were offered at Virginia Theological Seminary, one focusing on youth programming, and the other on an update of the latest in resources for Episcopal Christian education and formation;

- Travel to Nashville, Tennessee in May to participate in a week long national continuing education program that focused on preaching;
- Participation in October at the Diocese's fall clergy retreat with Michael, during which we participated in sessions addressing "*The Spirituality of Conflict*"; and
- Participation in an October program on "*Internet Safety in Ministry*."

My ministry with you during 2010 was one that brought me great joy. As I look forward into 2011 and to my ministries with all at TFCE, I am excited about the energy I see being poured into planning and preparing for the life of our church as we strive with God's help to live into the fullness of the life and mission of TFCE.

Past musical highlights, graciously hosted by the Fetsch family, have included our annual summertime Ladies Tea with jazz and classical piano accompaniment and a Christmas Congregational Gathering ending with a spirited carol-fest accompanied by several pianists including our own Kate Anderson! Our choir participated in our First Annual traditional December Holiday Sing-Along at the outdoor

CHRISTIAN EDUCATION COMMITTEE

TFCE's Christian Education Committee is charged with oversight, planning, and coordination of lifelong Christian education.

Christian Education takes many forms at TFCE, including Sunday morning education for children, teens, and adults, small group Bible study offered at church and also in the homes of our members. In the fall of 2010 it included special events such as TFCE's annual Shrine Mount retreat, where the very gifted speaker and author Rev. Barbara Crafton led participants in a deeply meaningful exploration of spiritual practices of forgiveness. TFCE carried Christian education into our surrounding community in some unexpected places—places like Starbucks, and Madison Park where parents worked with children and a local naturalist to install a new Children's Sensory Garden as they learned more about stewardship of creation.

Throughout 2010, as TFCE has continued to grow, so too did the variety and opportunities for ongoing Christian formation.

Looking ahead in 2011, the Christian Education Committee has recently been charged by our Priest-in-Charge to consider TFCE's long-term Christian Education and the depth and breadth of programming that will best serve our growing community. The Committee begins this process early in February and will issue a report of its findings to Fr. Pipkin and the Vestry. The ministry of Christian education is a vital one. At its roots is our very connection to our baptismal covenant, and through this, to our relationship with God and with one another. As we plan and prepare for our life and ministries as the people of The Falls Church (Episcopal), Christian education serves to lay a foundation for all else that we hope to achieve.

This past year has been a year of transitions for adult Christian education and formation. In the spring of 2010, it began to become clear that the Wednesday night adult education program that had been going continuously for two years was not gaining traction. As a result, the leaders of our adult Christian formation programs determined to break it down into different parts. Rev. Cathy Tibbetts had already been leading a women's Bible study group Sunday afternoons. We added to this a Wednesday night book group, which has read *Tokens of Trust*, by the Most Rev. Rowan Williams, *Yes! We'll Gather at the River*, by Rev. Barbara Crafton, and *The Screwtape Letters*, by C.S. Lewis. We also added a Sunday morning class, which has read the Gospel of Mark, done a short Advent series, and is now studying the life and theology of the German Lutheran minister and martyr Dietrich Bonhoeffer.

In conclusion, we offer thanks to God for the leadership of Mike Lockaby, Margret Hjalmarson, Doug Hansen and Matt Rhodes for their leadership on the committee this past year; the many parents who continue to give so graciously of themselves each Sunday as they teach our children about God our place in His unfolding history; and also for our latest addition Tyler Fox whose ministry with our youth is really taking off.

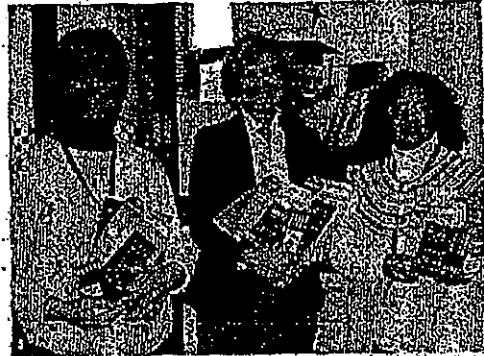
Everyone in the parish participates in Outreach; however, "official" Committee members are Lillian Anderton, Elizabeth Bass, Sally Brett, Neal Callander, Cary Cavness, Kathi and Kees Dutilh, Robin Fetsch, Gretchen and Mike Snyder, Edie Smolinski, Nancy Councilor, and *ex officio* member Jim Councilor.

During 2010, the TFCE Outreach Committee organized and supported several opportunities for our parish to serve our community and world. These ministries included Dinners for the Falls Church Homeless Shelter (Lillian Anderton, Sally Brett, Nancy Councilor); our second annual Rebuilding Together project, which helps to rebuild the home of one of our neighbors (Neal Callander and Kees Dutilh); participation in the Jazz in June fundraiser for the Falls Church Community Service Council, which raised \$6000 for the food bank and emergency needs program (Robin Fetsch, Gretchen Snyder, Kathi Dutilh); Care Packages for the Troops, which packed 27 care packages that were sent to men and women in the Armed Forces who are deployed abroad (Sally Brett); we donated 22 Backpacks full of school supplies for the Patrick Henry Family Shelter (Lillian Anderton); we organized a local fundraiser and awareness project with Fannie Mae Walk for the Homeless (Robin Fetsch), raising \$1400 for our ministry partner,

Shelter House in Falls Church; we donated Thanksgiving baskets and gift cards to 10 Homestretch families and one parish friend (Gretchen Snyder and Edie Smolinski); we donated boxes of food and clothing items for the Troops (Sally Brett and Cary Cavness); we adopted 4 families living at the Patrick Henry Family Shelter (Robin Fetsch and Kathi Dutilh with contributions by many parishioners); made monetary donations to Homestretch Kids Go Christmas Gift Shopping project (Gretchen Snyder), and distribution of school supplies for Homestretch (Sally Brett) and J.E.B. Stuart High School (Nancy Councilor). On top of that, each month we collected foodstuffs for our local food pantry at FCS, we collected emergency disaster response items after the earthquake in Haiti, and, we supported our own Junior Warden,

Deborah Miller, RN as she embarked on a mission trip to Haiti to help with relief efforts at St. Damien's Pediatric hospital in Tabarre, Haiti. With the prayers and blessings of

TFCE, she remained healthy and energetic, spending 10 days in the orthopedic clinic working with injured children and adults. (Although the short-term efforts of one individual appear puny in the face of overwhelming need, the gift of mercy was given on behalf of TFCE and gratefully received by the families Deb encountered. We continue to pray for the people of Haiti for an end to their suffering and that they would feel God's grace.)

Locally, our Rebuilding Together partnership is an example of the kind of integrated effort we are looking for (although it excludes younger parishioners, whom we also hope to bring to the committee). We hope to keep a calendar on the parish website and in a parish booklet to be available on the table at worship services, so that parishioners would not feel blindsided by "sudden" appeals for time, money, contributions, and the like. We also decided to take a team captain approach, with individual committee members encouraged to take charge of the project but to enlist parishioners who are not necessarily on the committee roster. We voted unanimously to return unused funds from our budget to the parish.

For 2011, the committee budget reflects a commitment to Rebuilding Together, For the Troops, Christmas families from Homestretch and Patrick Henry Shelter, and Thanksgiving baskets. Other commitments on the part of the committee and the parish "coworkers" will be the subject of discussion and decision at the January organizational meeting. We give thanks for Kathi Dutilh who has been elected by the Outreach Committee to serve as our Chairperson for the next year. We are hopeful that our Outreach projects will serve as a means for bringing together the parish and the parish with the larger community; they might also serve as the vehicle for greater youth involvement in parish life.

Thanks to everyone for your generous and loving donations of time, talent, and needed items. May we all continue not only to be blessed but to share those blessings with others.

ALTAR GUILD

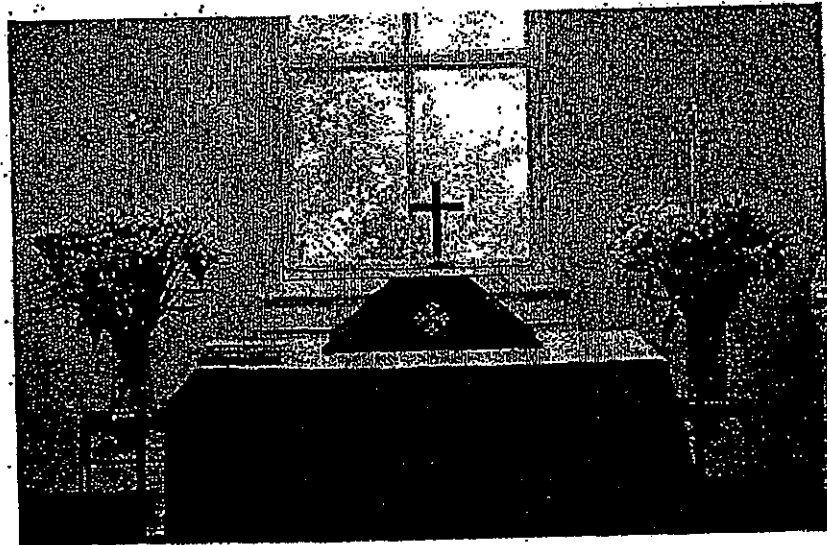

The Altar Guild members volunteer (in advance through email) to serve approximately two times per month. Usually two members serve each Sunday. As a reminder, a service calendar and altar setting instructions are posted in the sacristy closet. The Altar Guild members arrive in the Loft by approximately 9:15 to prepare the altar table for Sunday Communion Service (and for special services), throughout the year. Preparing the altar takes approximately 25 minutes, leaving the sacristy area free for Fr. Michael and Cathy to prepare for service uninterrupted.

Fr. Michael held an Altar Guild training session at the beginning of 2010 and unveiled a beautifully organized sacristy closet, including labeled wire baskets, which hold the gifts and supplies used to prepare the Altar. Those who can participate polish the altar silver and brass twice a year, at Easter and Christmas.

STEWARDSHIP OF CREATION COMMITTEE

The Parish Stewardship of Creation Committee continued its work this past year of taking our faith concerns for the environment and applying them to projects outside the doors of our shared church building. We were involved with four environmental projects that allowed us to witness our concerns for God's natural world in faith-related efforts. Our work included the following:

- Earth Day support and involvement;
- Two separate Tree Planting projects;
- Support for the City of Falls Church's Annual Clean-up Day; and
- Invasive Species Removal Projects with the City of Falls Church.

Next year's environmental support activities will begin in the spring with Tree Plantings. Later we will join forces with the City of Falls Church in local support with Earth Day projects.

TREASURER'S REPORT

Mr. Jim Councilor, Treasurer

For the year ending December 31, 2010, we had total income of \$233,641, which was up slightly (2%) from 2009. This increase in income represents a combination of fulfilled pledges, donations (both restricted and unrestricted) and income related to Shrine Mont registrations. Our operating expenses for the year totaled \$249,406, and can be summarized into the following categories:

For the second year in a row we will close out the year with a deficit, with this year's deficit totaling \$15,765. While seemingly high, this significant deficit is, in fact, largely the result of several expenditures meant to improve our administrative capacity.

First, in February, the Vestry approved the expenditure of \$1,000 for the purchase and set up of Church Administration Software through ACS Technologies. The new software enables us to maintain a membership database that, once we have finished updating all of the information, will give us the ability to publish on-demand directories, manage email communications more efficiently, report on trends, and even store photographs and detailed information that is all keyword and demographically searchable. The best part of our new software is the ability for multiple users to access the software through the Internet, giving our parish leaders the ability to access the information that they need to administer the various programs and ministries of our parish. The information is always secure, and it is backed up daily through ACS's secure servers.

The second major expenditure was the increase in our Building Use Fee. Before this year we had been giving Falls Church Presbyterian Church (FCPC) \$300 per month as a "Thank You" for the use of their spaces. In late 2009, the leadership of FCPC approached us with the possibility of moving our offices into their church, giving us, for the first time, a central administrative office. Accordingly, and because we rely so heavily on space at FCPC for all of our worship and programs, we increased our giving to FCPC from \$300 per month to \$750 per month. With that increase, we have not only been able to use room 303 as an office for our clergy staff, but we also gained the use of FCPC's Building Manager, Romero Corto, for a few hours per week to help move chairs and provide some program support.

With the office space secured, the Vestry moved to provide furnishings and utilities for the office. Thanks to Michael Gardner, we were introduced to a furniture broker who was

able to secure high quality office furniture at a greatly reduced cost. Other costs included upgrades to the office's electrical circuits, which were necessary due to the increased load of computers and a copier (special thanks to Kees Dutilh for contracting this work for us), painting supplies (labor was provided by Michael Pipkin and Cathy Tibbetts), and the setup of telephone and Internet lines. In all, the total cost for the office setup was \$6,973. While this number adds to the deficit of our 2010 Budget, it is offset in our 2011 Budget by a grant from the Diocese of Virginia for \$5,000, which was not received until January 2011.

Besides the Administration Software, the increased Building Use Fee, and the costs associated with establishing our office, we are experiencing the addition of recurring costs for telephone, internet, and an increase in the need for office supplies such as paper, ink, toner, etc., all of which are the outcomes of the significant growth in our church over the past four years.

No matter what the reason, it is clear that this deficit cannot be sustained as we move forward. Without increased income, our Vestry will need to make some difficult operational decisions to ensure that we operate within our means.

In the recently completed fall pledge campaign, once again nearly 90% of our members made a financial commitment to our parish and our mission and work in our local community. Many of our parishioners utilize the electronic payment option (provided by Vanco Services), and several more use their bank or credit union electronic check payment services. Either of these options makes it easy to donate, and helps maintain regular contributions—particularly when it isn't possible to attend worship services. If you are interested in participating in electronic payments, please contact me.

Our parish has grown and matured significantly since January 2007, and it has been an honor and a rewarding experience for me to serve as Treasurer. Thank you for your confidence and many kind words.
