Catechist

A Catechist is a lay person who is authorized to prepare persons for Baptism, Confirmation, Reception, and the Reaffirmation of Baptismal Vows, under the direction of the Member of the Clergy who oversees the congregation or other community of faith.

Qualifications

Confirmed communicant in good standing
Faithful in worship and in stewardship
Mature in faith
Of good repute in the congregation
Demonstrated gifts of teaching and discernment

Training

Completion of a course of training and study, under the supervision of the rector or other priest, to include a study of

- The teachings of the church as found in the Creeds
- The teachings of the church as found in An Outline of the Faith, commonly called the Catechism
- The Holy Scriptures
- Church History, Christian Ethics and Moral Theology
- The Canons of The Episcopal Church
- Methods of teaching
- Sexual Misconduct Prevention Training

General Information for clergy seeking Catechist licenses for lay people in their congregations:

- 1. Clergy requesting licenses should ensure that those licensed in the congregation represent the diversity of the Church, and include women, men, young people (16 years or older) and older persons, as well as persons of different racial and ethnic backgrounds.
- 2. Licensed lay ministers who are functioning liturgically may vest in either alb and cincture or surplice and cassock, according to parish custom.
- 3. Licenses are issued for three years.
- 4. Those who are in a formal formation programs for the priesthood or vocational diaconate in the Diocese of Virginia are deemed to be licensed under these guidelines.
- 5. Before a license may be granted, the applicant must complete training in the prevention of sexual misconduct.
