

## REPORT OF THE COMMITTEE ON CONSTITUTION AND CANONS

After receiving comments at our open hearing and other comments, the Committee on Constitution and Canons respectfully reports:

**C-1** The Committee recommends **Adoption** of C-1 on second reading. The Committee requests that C-1 be placed on the Consent Agenda.

**C-2** The Committee recommends **Adoption** of C-2 on first reading.

**C-3** The Committee recommends **Adoption** of C-3.

**C-4** The Committee recommends **Rejection** of C-4.

Rationale: The issue can be addressed by an amendment to the Canons (see C5a below) and does not require an amendment to the Constitution.

**C-5a** The Committee recommends amendments to Canon 2 to add a new section 7 as stated below:

Canon 2, Section 7. Youth Delegates. Each Region of the Diocese may elect one Youth Delegate and one Alternate Youth Delegate to the Annual Convention. Youth Delegates shall be confirmed communicants in good standing, ~~between~~ under the ages of sixteen and twenty-one (21) at the time of their election, and shall have seat, voice, and vote in the Convention. The election of Youth Delegates shall take place at a duly called meeting of the Regional Council on or before May 1 each year. ~~Provided, however, that~~ Any Regional Council which has not elected its own Youth Delegate may elect any otherwise-eligible youth confirmed communicant in good standing of a congregation in this Diocese without regard to the youth's home congregation or region. Certification of election shall be submitted to the Secretary of the Convention in accordance with established procedures.

The Committee recommends **Adoption** of C-5a with the amendments stated above.

**C-6** The Committee recommends a resolution to further address the issue of Youth Delegates as follows:

### A Resolution Supporting Youth Delegates to Diocesan Convention

Resolved, that the 231st Annual Convention of the Diocese of Virginia affirms the vital role of youth in the life and governance of the Church, and celebrates the presence and contributions of the Official Youth Presence at the General Convention of The Episcopal Church; and be it further

Resolved, that this Convention acknowledges with concern the declining number of youth delegates elected to recent Diocesan Conventions, and recognizes the barriers—logistical, procedural, and relational—that may hinder youth participation in diocesan governance; and be it further

Resolved, that the Secretary of the Diocese of Virginia be requested to explore and develop practices and procedures that would support youth delegates to Diocesan Convention, including but not limited to:

- Clear nomination and election guidance for youth eligibility and discernment
- Orientation materials and mentorship opportunities for youth delegates
- Logistical support for travel, lodging, and scheduling accommodations
- Collaborative engagement with youth ministries and parish leaders to identify and empower potential youth delegates; and be it further

Resolved, that the Secretary report findings and recommendations to the 232nd Annual Convention, with the goal of strengthening youth representation and leadership in the governance of the Diocese of Virginia.

Rationale::

The Episcopal Church has long affirmed the leadership of young people, most visibly through the Official Youth Presence at General Convention and by Canonical provisions in the Diocese of Virginia. In recent years, the Diocese of Virginia has seen a decline in youth delegates elected to Convention, despite canonical provisions for their inclusion. A Canonical amendment will come before Council to offer more flexibility in the election of Youth Delegates but the Committee on Constitution and Canons feels that work beyond the Canons needs to be done. This resolution seeks to honor our baptismal commitment to “respect the dignity of every human being” by ensuring that youth are not only welcomed but equipped to participate fully in the councils of the Church.

The Committee recommends **Adoption** of resolution C-6.
