Each year, two clergy and two lay members are elected by the Annual Convention to three-year terms. The Standing Committee meets monthly in Fredericksburg to perform its canonical tasks. Bishop Stevenson regularly participates in the meetings as a guest.

Approving Candidates for Ordination

The formation process for ordained ministry (priesthood and diaconate) is a vital function of the diocese. The Standing Committee interviewed ten postulants, approving their progression towards ordination. We thank The Rev. Dr. Sarah Kye Price, - Vocations Minister, the Committee on Priesthood, and the Committee on the Diaconate for their collaborative work in this formation process.

Approving Indebtedness Requests to Encumber or Sell Property

The Standing Committee is a steward of real estate transactions within the diocese. Working in conjunction with our Diocesan Treasurer, Ted Smith, the status of seven properties was reviewed and requests for their sale approved. Encumbrance requests for two properties were also reviewed and approved.

Consenting to the Election of Bishops in The Episcopal Church

The election of a bishop in any diocese of The Episcopal Church must be consented by a majority of all Standing Committees of the all the dioceses. Bishop election consents were given for the dioceses of West Texas, West Missouri, Cuba, and Dallas.

Serving as a Council of Advice for the Bishop

During each meeting, Bishop Stevenson shares news of efforts around the diocese to love Jesus, embody justice, and be disciples. Bishop Stevenson sought advice on organizational developments within the diocese and various emerging issues. The committee provided thoughtful insights from our diverse perspectives. We enjoy a mutually respectful working relationship with Bishop Stevenson which allows for forthright and productive conversations.

Work Group Appointments

The Standing Committee offered advice, consent, and nominations on appointments of Regional Deans, Disciplinary Board members, and Truth and Reparations Task Force restructuring and member composition.
